CRIME VICTIM RIGHTS

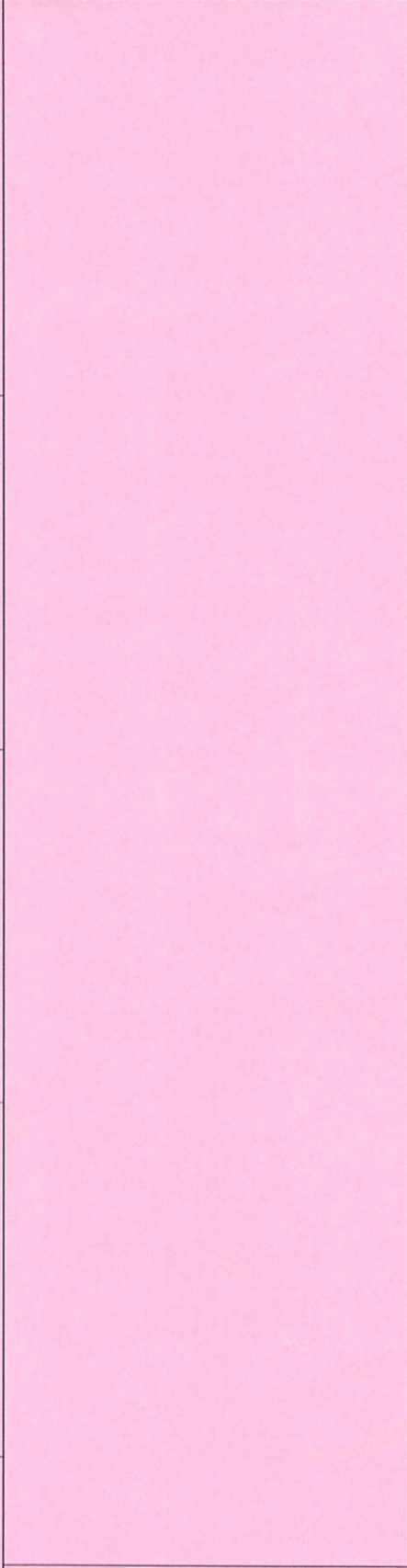
