  - 1) 10-year Employee Recognition: Roxan Schwartz (Transportation).
  - 2) Motion to ratify the FY 2019 Continuum of Care Program Grant Agreement that includes amended line item amounts but not an amended total.
  - 3) Personnel Action/Salary Board
    - a) Motion to approve a 4.5 percent pay increase for Roxan C. Schwartz for reaching her 10-year anniversary with the county Transportation System, per the county's approved compensation plan. Set the new salary at \$16.64 per hour, or \$32,572.80 annually, effective Feb. 22, 2021. She remains a 30A at 37.5 hours per week.
    - b) Motion to hire Chris Crellin as a part-time, work study employee with the Information Technology Department from Feb, 22 through May 31, 2021. Set salary at \$11 per hour for a 37.5-hour work week.
    - c) Motion to hire Christopher Stein to a full-time position with the Information Technology Department effective March 8, 2021. Set salary at \$21.60 per hour, or \$42,120 annually, for a 37.5-hour work week.
    - d) Motion to promote Angela Lauffenberger to a full-time County Caseworker 2 at BH/ID/EI/A, effective Feb. 22, 2021. Her hourly salary remains the same at \$17.38 but her hours would increase to 37.5, making her eligible for county benefits.

- e) Motion to promote Dakota Knehr-Cook to a full time Correctional Officer effective February 21, 2021. Set salary at \$17.21 per hour, or \$35,796.80, for a 40-hour work week.
- f) Motion to approve 2.5 percent pay increases, retroactively to Jan. 1, 2021, for the 20 former members of the AFSCME Court-Related Bargaining Unit.
