

The regular meeting of the Wayne County Commissioners was held on this date with Commissioner Brian W. Smith presiding. The meeting was called to order by Chairman Smith with Commissioner Joseph W. Adams and Commissioner Jocelyn Cramer present.

The Commissioners were presented with a copy of the minutes from the meeting held January 20, 2022. A motion was made by Commissioner Cramer, seconded by Commissioner Adams and unanimous to approve the minutes of the said meeting.

Agenda

Scheduled to meet with the Commissioners: Kelly Lewis – Wayne County Broadband Survey.

Items to be considered: Employee anniversary recognition; Adopt Resolution 27-01-2022; Grant application for \$20,000 from the Pennsylvania Veterans Trust Fund; Salary Board meeting; Payment of bills.

Correspondence and Communications

Received a notice from Kiley Associates, LLC, regarding their intent to submit an application to the PA Department of Environmental Protection for a dock permit on Lake Henry, Lake Township.

Received a letter from Pennsylvania American Water informing the County and communities within, it is once again offering its Environmental Grant Program in 2022 in its service territory.

Received a letter of resignation from Law Clerk Joseph Saporito, III, effective February 11, 2022. A motion was made by Commissioner Cramer, seconded by Commissioner Adams and unanimous to recognize this resignation.

New Business

The Commissioners held an employee anniversary recognition. The following County employees were in attendance:

Administrator Roz Burke and County Caseworker Ashley Starnes introduced Cindy Morales, Clerical Supervisor, and Karen Bates, Social Services Aide 3. Ms. Burke called Ms. Morales the backbone of the clerical unit and phenomenal for our team overall. Ms. Starnes said Ms. Bates held 15 years with the agency showing dedication and commitment to those we serve. The Commissioners told them we appreciate people like them with experience and dedication. Working with children and youth can be daunting, but sticking with the County for 15 years is extremely meaningful.

Administrative Officer Carl Albright introduced Joni Stark, Transportation Dispatcher on her one year anniversary. Mr. Albright said she has a vast knowledge of Wayne County which helps with dispatching. She is pleasant and efficient on the phone. The Commissioners told Ms. Stark they hope this is one year of many more with the County.

Leo O'Neill, who was not present, has completed five years in the Maintenance Department and a certificate will be delivered to him.

January 27, 2022

Kelly Lewis gave an update on the County broadband survey. He said holding an employer survey has helped identify the dead zones and what broadband is out there and the cost. Mr. Lewis said they have received over 1,000 responses to date and their goal is to more than double that. He lauded Wayne County for having a broadband committee in place and actually trying to address this problem. Mr. Lewis said the goal of this project is to get service throughout the County with lower rates.

Commissioner Smith said this is the first time we have a large pool of money the County can dedicate to this problem. He thanked Wayne Tomorrow for their network of contacts and partners in place to be able to collaborate and get the word out quickly. Commissioner Adams thanked the William H. Chatlos Charitable Gift Fund for paying for a consultant. Commissioner Adams believes the County will get really good results from this survey. Commissioner Cramer said every rural community in the county is in the same boat and having Kelly Lewis on board puts us ahead of the curve. Community Network Specialist Kim Rickard said we are excited to get this out and see the regions cell and broadband coverage improve in Wayne County to attract more business and improve the lives of residents. CFO Vicky Botjer said the County has lots of money available for broadband, but are trying to match up the projects with the available needed money.

Transportation Administrative Officer Carl Albright explained what the Title VI plan does for the County. A motion was made by Commissioner Adams, seconded by Commissioner Cramer and unanimous to adopt Resolution 27-01-2022 adopting a Title VI plan for the Wayne County Transportation System.

A motion was made by Commissioner Smith, seconded by Commissioner Cramer and unanimous to ratify the filing of a grant application for \$20,000 from the Pennsylvania Veterans Trust Fund on behalf of the Wayne County Office of Veterans Affairs.

A motion was made by Commissioner Adams, seconded by Commissioner Smith and unanimous to transfer Elizabeth Ennis from County Caseworker 2 in the Housing Department to County Caseworker 2 at Children and Youth Services, effective February 28, 2022.

At this time, the Commissioners recessed to hold a Salary Board meeting. [See Salary Board minutes.](#)
