 3. To vote for a Ballot Question: Blacken the oval to the left of the word "Yes" to vote for the question. Blacken the oval to the left of the word "No" to vote against the question.
 3. If you make a mistake, do not erase it. Ask for a new ballot.
 4. Use a black or blue pen or pencil.
